prescribed by the U.P. Secondary Education Council/ Basic  
Education Council.

Organization shall not demand any aid from the State Government  
and if the affiliation is earlier taken from Central School Education  
Council or is from Central Board of Secondary Education, New  
Delhi/ Council for the Indian School Certificate Examination, New  
Delhi then from date affiliation given by U.P. Secondary Education  
Council and State Government was cancelled automatically.

6. Terms and conditions of the Service of the employees shall be made and they shall be benefited as per the employee of other Government aided school.
7. Organization will obey the instructions given by State Government.
8. Record of the School shall be maintained in the prescribed books.
9. In all the above conditions no change shall be made without the prior approval of the State Government.

Organization is bound to obey the above conditions and if at any stage it came to the knowledge that the above mentioned rules are not fill or there is any misake to obey the same or taken lightly then the no objection certificate granted by the State Government shall be taken back.
